I repaired the screens on two of our portable radios by using parts from two of the damaged radios we received from Ceres. I am currently going through the radios that we received from Ceres and Salida and will program the ones in the best condition.

Accountability – I have issued the Engineers radios and have created a system for Reserves/Volunteers to checkout radios while they are working and maintaining accountability.
